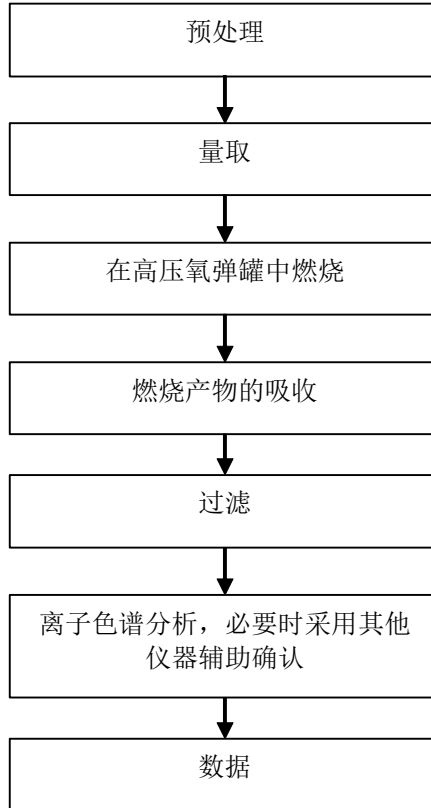

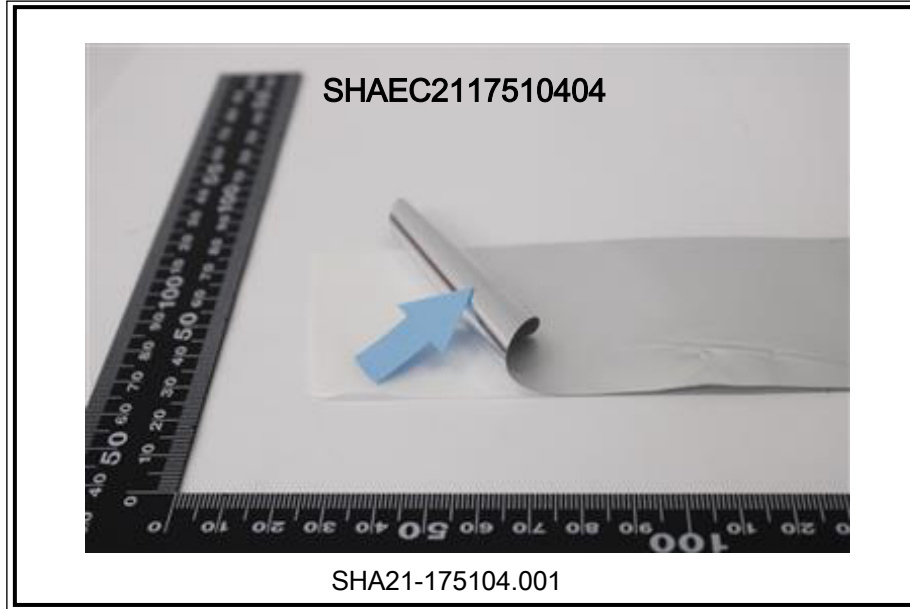
## Halogen(氧弹法)测试流程图
